### (1) Abstract Submission

You are cordially invited to submit an abstract of your paper for consideration. An Application Form and an abstract based on the abstract template should be submitted by E-mail to the jepa mail address stated below, in the form of **MS-Word file** by ~~May~~ **July 31, 2019**. Abstracts and papers must **neither** have been published, accepted, **nor** have been submitted for publication elsewhere.

### (2) Required Contents

The abstract based on the abstract template should be written **in one page** and is required to contain the following:

1. Title of the paper
2. Name(s) of author(s) (the surname in CAPITALS)
3. Affiliation(s) and post(s), postal address(es), telephone/fax numbers and E-mail address(es)
4. Abstract (of **450~500 words**, three key words, single spaced)
5. Category Number (s) listed below and JEL classification code

### (4) Full Paper Submission

An Application Form and a **MS-Word file** of your full paper should be submitted by E-mail to the jepa2019 address stated in (6) by ~~July~~ **August 31, 2019**. Your paper based on the full paper template should be written in English, in the format of **80 letters by 40 lines per page**, and be accompanied by the abstract. The length is expected to be **around 20 pages**, including all formulae, references, tables and figures. The full paper template is available on the above website.

### (5) Process of Selection

The Program Committee will examine the submitted papers, decide if they are worth for presentation or not, and will notify the results to the presenter.

A presenter whose paper is accepted will be expected to play the role of a discussant and/or a session chair.
